

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to gabriellegarofalo.com, and Gabrielle Garofalo Inc. and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Gabrielle Garofalo Inc. include gabriellegarofalo.com. Collection of your Personal Information

In order to better provide you with products and services offered, Gabrielle Garofalo Inc. may collect personally identifiable information, such as your:

Sharing Information with Third Parties
